#### 1 ABBREVIATIONS AND ADDITIONS

Standard rules - Standard rules for admission to study in education organizations implementing education programs of higher education and postgraduate education, approved by the order of the Minister of Education and Science of the Republic of Kazakhstan dated October 31, 2018, No. 600 (as amended in accordance with the Order of the MSHE RK No. 212 dated 03.05.2024) (hereinafter - Standard rules).

#### 2 GENERAL PROVISIONS

- 2.1 These rules for admission to study at JSC International Information Technology University (hereinafter referred to as the University) have been developed in accordance with the Law of the Republic of Kazakhstan dated July 27, 2007 "On Education", the Law of the Republic of Kazakhstan dated April 15, 2013 "On Public Services", the Model Rules for Admission to Study in Education Organizations Implementing Education Programs of Higher Education and Postgraduate Education, approved by order of the Minister of Education and Science of the Republic of Kazakhstan dated October 31, 2018 No. 600 (as amended in accordance with the Order of the MSHE RK No. 212 dated 03.05.2024) (hereinafter referred to as the Model Rules), determine the procedure for admission to study and the formation of the student contingent of the University.
- 2.2 Admission of persons entering the University is carried out through the placement of a state education order and an education grant for higher education at the expense of the republican budget, as well as payment for tuition at the expense of the student's own funds and other sources.
- 2.3 Admission of persons entering the University is carried out in accordance with the list of education programs for admission of applicants approved by the Academic Council of the University (Minutes No. 9 of April 29, 2024) (Appendix 1).

#### 3 ADMISSION PROCEDURE

- 3.1 The University accepts persons with general secondary, technical and vocational, post-secondary, and higher education.
- 3.2 Persons with secondary, technical and vocational or post-secondary education, with the exception of applicants in related areas of higher education training that provide for shortened periods of study, who have passed the UNT and scored the following (see below) according to its results, are allowed to participate in the competition for the award of an education grant for higher education at the expense of the republican budget and (or) enrollment in paid education.
  - at least 80 points in the areas of training such as "Information and Communication Technology" (except for GEP "Communications and Communication Technologies"), to participate in the competition for the award of an education grant for higher education at the expense of the republican budget.
  - at least 60 points to participate in the competition for the award of an education grant for higher education at the expense of the republican budget, in the following GEP:
  - B 059-"Communications and Communication Technologies";
  - B 042-"Journalism and Reporting";
  - B 044-"Management and Administration";
  - B 059-"Finance, Economics, Banking and Insurance".
  - at least 50 points in all areas of training for admission to paid education.

In this case, it is necessary to score at least 5 points in History of Kazakhstan and two specialized subjects of the UNT and (or) the creative exam, and at least 3 points in the subjects of Reading Literacy and Mathematical Literacy.

- 3.3 Persons with technical and vocational, post-secondary education who have passed the UNT and scored at least 25 points, including at least 5 points for each UNT discipline and (or) creative exam, are allowed to participate in the competition for the award of an education grant for higher education at the expense of the republican budget in related areas of training, providing for shortened periods of study.
- 3.4 The applicant participates with one of two UNT results with the required number of points in the electronic form of UNT to compete for the award of an education grant for higher education at the expense of the republican or local budget.
- 3.5 Persons who have a KAZTEST certificate confirming proficiency in the Kazakh language, not lower than B1 (intermediate) level, are exempted from taking the core subject or special discipline of the UNT "Kazakh Language" at their own discretion and participate in the competition for an education grant and (or) are enrolled in the higher and postgraduate education organizations (HPEO) in the fee-paying department, in accordance with the scale of point conversion, according to Appendix 2-2 to these Model Rules.
- 3.6 The conversion of SAT scores into UNT scores is carried out subject to the availability of SAT reasoning and SAT subject certificates. At the same time, applicants take the UNT in the subject History of Kazakhstan and SAT subject scores are converted into UNT points provided that the core subjects match.
- 3.7 The University administers an exam to determine the level of English language proficiency of applicants and sets a passing score for applicants.
- 3.8 Applicants who provide one of the following certificates of English language proficiency are exempt from this exam:
  - 3.8.1. IELTS not less than 5.0 points.
  - 3.8.2. TOEFL ITP not less than 460 points.
  - 3.8.3. TOEFL IBT not less than 46–59 points.
- 3.8.4. University certificate of passing the English language exam not less than 30 points out of 50 (60%).
- 3.8.5. Certificate of completion of the "IITU Academic English Course" at the University's language center "LINGUA";
  - 3.8.6. Certificate of "KBTU" JSC on passing internal entrance exams;
  - 3.8.7. Certificate of Astana IT LLP on passing internal entrance exams;
- 3.8.8. Certificates of completion of courses on the programs of internal entrance examinations at KBTU JSC or Astana IT LLP.
- 3.9 The University reserves the right for the applicant to provide one of all the above certificates during the entire period of work of the Admissions Committee until August 25, 2024.
- 3.10 In the absence of the certificates listed in paragraph 3.8, the applicant undertakes to take the IITU Academic English Course at the LINGUA language center of the University.
- 3.11 The procedure for registration, conduct, form, and passing of the level exam are determined by the Rules for determining the level of English language, conducting additional exams and interviews for applicants to education programs (bachelor's degree) of the "International Information Technology University" JSC for the 2024-2025 academic year And the University Instructions for passing the test to determine the level of English language proficiency.
- 3.12 An applicant is admitted to the University subject to passing the English language level examination and achieving the passing score established by the University.
- 3.13 Citizens of the Republic of Kazakhstan who have technical and vocational, post-secondary education are accepted for training in higher education programs that provide for shortened periods of study.
- 3.14 Admission to the University of persons with technical and vocational or post-secondary education with the qualification of "mid-level specialist" or "applied bachelor" in related areas of training higher education personnel, providing for shortened periods of study, entering on a fee-paying basis is carried out by the Admissions Committee.

- 3.15 Admission of citizens with general secondary education who have completed their compulsory military service to study on a fee-paying basis is carried out within two years after completing their compulsory military service based on the results of an interview conducted by the Admissions Committee during the calendar year. Enrollment of citizens who have completed their compulsory military service is carried out in accordance with the academic calendar 5 (five) days before the start of the next academic period.
- 3.16 Citizens of the Republic of Kazakhstan who have completed their compulsory military service and have technical, vocational, post-secondary or higher education are accepted within two years after completing their compulsory military service for training on a paid basis in education programs with shortened training periods based on the results of an interview conducted by the Admissions Committee during the calendar year. In this case, the enrollment of citizens who have completed their compulsory military service is carried out in accordance with the academic calendar 5 (five) days before the start of the next academic period.
- 3.17 Admission of persons entering the University is carried out on the basis of their applications on a competitive basis in accordance with the points of the certificate in the established form approved by the order of the Acting Minister of Education and Science of the Republic of Kazakhstan dated October 23, 2007 No. 502 "On approval of the form of strict reporting documents used by education organizations in education activities" (registered in the Register of state registration of regulatory legal acts under No. 4991) and (or) an electronic certificate with unique data of the applicant, officially confirming the results of the unified national testing (UNT) published on the website of the National Testing Center (hereinafter the UNT certificate).

## 4 PROCEDURE FOR CONDUCTING CREATIVE EXAMINATIONS

- 4.1 Admission to higher education in groups of education programs requiring creative training, including "Journalism", is carried out considering the results of creative examinations.
- 4.2 To organize and conduct creative examinations, by decision of the Chairman of the Board Rector of the University or the person performing the duties, an examination committee is created for the period of the examination.
- 4.3 The committee includes representatives of the University's faculty, public organizations, and the media.
- 4.4 The committee consists of an odd number of members, and the chairman of the committee is elected by a majority vote of the members of the committee. The decision of the committee is considered valid if at least two-thirds of its members are present at the meeting. The decision of the committee is made by a majority vote of those present at the exam. In the event of a tie, the vote of the Chairman of the committee is decisive.
- 4.5 Creative examinations are conducted according to the groups of education programs "Journalism", in accordance with the List of groups of education programs for which creative examinations are conducted in accordance with Appendix 1 to the Model Rules.
- 4.6 Persons applying for higher education programs in "Journalism" submit the following documents to the University Admissions Committee to take creative exams:
  - 1) document on general secondary or technical, vocational, post-secondary education (original);
  - 2) 2 photographs 3x4 cm;
  - 3) a copy of an identity document;
  - 4) UNT certificate (if available).
- 4.7 Applications for the creative exam will be accepted from June 20 to August 10 of the calendar year.
  - 4.8 The creative exam is held from July 7 to August 15 of the calendar year.
- 4.9 Persons entering a group of higher education programs requiring creative training, who have documents on general secondary, technical and vocational or post-secondary education, take two creative exams.

- 4.10 Persons entering a group of higher education programs requiring creative training in related areas of training of higher education personnel, providing for shortened periods of study, take one creative exam.
- 4.11 The form of conducting creative examinations is established in accordance with Appendix 2 to the Model Rules.
- 4.12 Persons entering the group of higher education programs "Journalism" take creative exams at the University.
- 4.13 For persons with secondary or technical and vocational, post-secondary education, entering a group of higher education programs requiring creative training, points in the History of Kazakhstan, and Reading Literacy (in the language of instruction) are taken into account.
- 4.14 For persons entering a group of higher education programs requiring creative training in related areas of higher education personnel training, which provide for shortened training periods, points in a special discipline are taken into account.
- 4.15 The programs for conducting creative examinations are developed and approved by the Chairman of the Admissions Committee.
- 4.16 The schedule of creative examinations (examination format, date, time and place, consultations) is approved by the Chairman of the Admissions Committee and is communicated to applicants before the start of document acceptance.
- 4.17 Admission to the auditorium (room) where creative examinations are held is granted upon presentation of an identity document.
- 4.18 Creative examinations are held in classrooms (rooms) equipped with video and/or audio recording.
- 4.19 Before the start of the creative examinations, applicants are given examination materials and the procedure for the title pages design is explained, as well as the start and end time of the special and (or) creative examinations, the time and place of the announcement of the results, and the procedure for filing an appeal.
- 4.20 Creative exams for applicants who have documents on general secondary or technical and vocational, post-secondary education are assessed on a 50-point scale.
- 4.21 The results of the creative exam are recorded in a grade sheet, the results of the special exam are recorded in a pass sheet in a committee Minutes in any form and are transferred to the executive secretary of the Admissions Committee (or the deputy) for the announcement of the results. The committee Minutes is signed by the chairman and all present members of the committee.
  - 4.22 The results of creative examinations are announced on the day of the examination.
- 4.23 During the period of examinations, in order to comply with the requirements imposed on the creative examination, resolve controversial issues, and protect the rights of persons taking the relevant examinations, an appeals committee shall be created by order of the Chairman of the Board Rector or the person performing the duties, which shall consist of an odd number of members, including its chairman.
- 4.24 An appeal application is submitted to the chairman of the appeal committee in person by the person who took the creative exam, is accepted until 13:00 the following day after the announcement of the results of the creative exam and is considered by the appeal committee within one day.
- 4.25 The decision of the appeal committee is considered valid if at least two-thirds of its members are present at the meeting. The decision on the appeal of disagreement with the results of the creative exam is made by a majority vote of the number of members of the committee present. In the event of a tie among the members of the appeal committee, the vote of the chairman is decisive. The work of the appeal committee is formalized in a Minutes signed by the chairman and all members of the committee present.
- 4.26 On the day of completion of the creative exam, the results of the creative exam of applicants for participation in the competition for the award of an education grant for higher education at the expense of the republican budget and (or) enrollment in the University for paid education are transferred to the information system of the National Testing Center of the Ministry of Education and Science of the Republic of Kazakhstan.
- 5 PROCEDURE FOR ADMISSION AND CONDUCTING AN ENTRANCE EXAMINATION (INTERVIEW) WITH APPLICANTS HAVING TECHNICAL, VOCATIONAL OR HIGHER EDUCATION

- 5.1 Admission to the University of applicants with technical, vocational or higher education to education programs with shortened terms of study on a fee-paying basis is carried out through additional examinations and interviews. Submission of applications for participation in the interview and the interview itself are held from June 1 to August 24.
- 5.2 Before the interview, it is necessary to pass an English level exam and one exam in accordance with the "Rules for determining the level of the English language, conducting additional exams and interviews for applicants to bachelor's degree education programs at "IITU" JSC for the 2024-2025 academic year", approved by the Decision of the Board of "IITU" JSC dated "06" June 2024 (Minutes No. 18/24)
  - 5.3 The pass score for the additional exam to be admitted to the oral interview is 50%.
- 5.4 The interview is conducted by the committee according to the schedule approved by the chairman of the Admissions Committee.
- 5.5 Computer test materials for applicants to the University's education programs with shortened study periods are stored in the files of the Admissions Committee.
- 5.6 Oral interview includes the following questions: work experience in the chosen field of study; professional skills and knowledge.
  - 5.7 Learning objective.
- 5.8 Interviews with persons with higher education, technical and vocational education in a group of education programs that provide for shortened periods of study on a fee-paying basis are conducted by a committee approved by the chairman of the University's Admissions Committee. The committee includes the PPPS and employees of structural divisions, specialists from organizations and enterprises in the relevant industries.
- 5.9 To resolve contentious issues and ensure compliance with uniform requirements for applicants, an appeals committee is created, approved by the chairman of the Admissions Committee .
- 5.10 Applications for appeal are accepted until 13:00 the following day after the results are announced and are considered by the appeal committee within one day.
- 5.11 The work of the appeal committee is formalized by the minutes of the meeting of the appeal committee, signed by the chairman and all members of the committee.
- 5.12 The decision of the appeal committee is final and is not subject to revision. The appeal committee informs the applicant of the results of the appeal.
- 5.13 The results of the interview are drawn up in the minutes of the committee in the established form and are transferred to the executive secretary of the Admissions Committee for the announcement of the results. The minutes are signed by the chairman and all members of the committee present.

#### 6 ENROLMENT PROCEDURE

- 6.1 To be admitted to the University service recipients submit a package of documents, stipulated by paragraph 8 of the Public Service Standard "Acceptance of documents and enrollment in higher education institutions under higher education programs" (hereinafter referred to as the Public Service Standard), in accordance with Appendix 3 to the Model Rules, to the University's Admissions Committee (through the University's Admissions Committee) or through the "electronic government" web portal www.egov.kz (hereinafter referred to as the portal).
- 6.2 The list of basic requirements for the provision of public services, including the characteristics of the process, form, content and result of the provision of the service, as well as other information considering the specifics of the provision of public services, is provided in the Public Service Standard.
- 6.3 Ehe University's Admissions Committee accepts a package of documents, registers them and issues a receipt to the service recipient on the day of receipt of the application or, if the service recipient provides an incomplete package of documents, refuses to accept the documents.
- 6.4 In the case of an application through the portal, the service recipient is assigned a status on the acceptance of the request for a public service in the "personal account", as well as a notification indicating the date and time of receipt of the result of the public service.
- 6.5 The University's Admissions Committee checks the completeness of the submitted documents when they are received, and in case of incompleteness, prepares a reasoned refusal to further consider

the application, which is sent in the form of an electronic document to the applicant's "personal account" on the portal.

- 6.6 If the service recipient provides a complete package of documents, the University Admissions Committee issues a notification of acceptance of documents for enrollment at the University. After receiving the notification, the service recipient submits the original documents to the University Admissions Committee within the period from June 20 to August 25 of the calendar year.
- 6.7 After the documents are accepted by the Chairman of the Board Rector of the University, an order is issued to enroll the service recipient as a student at the University.
- 6.8 The University Admissions Committee refuses to provide a public service on the grounds provided for in paragraph 9 of the Public Service Standard.
- 6.9 The service provider ensures that information about the stage of provision of the public service is entered into the information system for monitoring the provision of public services in accordance with subparagraph 11 of paragraph 2 of Article 5 of the Law of the Republic of Kazakhstan dated April 15, 2013 "On Public Services".
- 6.10 A complaint against a decision, action (inaction) of a service provider on provision of public services may be submitted to the head of the service provider, to the authorized body for assessment and control over the quality of provision of public services, in accordance with the legislation of the Republic of Kazakhstan.
- 6.11 A complaint from a service recipient received by a service provider, in accordance with paragraph 2 of Article 25 of the Law, shall be reviewed within 5 (five) working days from the date of its registration.
- 6.12 A complaint from a service recipient received by the authorized body for assessment and control of the quality of provision of public services shall be considered within 15 (fifteen) working days from the date of its registration.
- 6.13 In cases of disagreement with the results of the provision of a public service, the service recipient shall apply to the court in accordance with the procedure established by the legislation of the Republic of Kazakhstan.
- 6.14 Enrollment of applicants as students at the University is carried out by Admissions Committee's from June 20 to August 25 of the calendar year by order of the Chairman of the Board Rector of the University or the person performing the duties.
- 6.15 Persons who have received an electronic certificate of award of an education grant for higher education at the expense of the republican budget or local budget, and who have scored the threshold points in the English level exam, submit an application for admission to the institution specified in the certificate and are enrolled as students by order of the Chairman of the Board Rector of the University or the person acting in this capacity.
- 6.16 Holders of an education grant for groups of creative higher education programs are enrolled in the University, subject to passing creative exams at the University.
- 6.17 Citizens of the Republic of Kazakhstan who are admitted based on a state grant enter into an agreement to work for at least 3 (three) years in the manner determined by the Government of the Republic of Kazakhstan.
- 6.18 Persons with secondary or technical and vocational, post-secondary education of the current year, who passed the UNT within the established deadlines in accordance with Order No. 204 and scored the threshold score established in paragraph 4 of the Model Rules, submit an application to the Chairman of the Board Rector of the University or the person performing the duties for enrollment in the University on a fee-paying basis until receiving a document on general secondary or technical and vocational, post-secondary education.
- 6.19 In this case, students of the 11th (12th) grades of secondary education organizations in the period from February 1 to August 25 of the calendar year submit an application to the Chairman of the Board Rector of the University or the person performing the duties for enrollment in the University on a fee-paying basis until receiving a document on general secondary education.
- 6.20 After receiving a document on general secondary or technical and vocational, post-secondary education, applicants submit documents according to the list specified in the Model Rules.
- 6.21 Persons who have scored the threshold established in paragraph 4 of the Model Rules, based on the results of the UNT, provided for in paragraph 5 of the Model Rules and paragraph 12 of these

Rules, shall submit an application to the Chairman of the Board - Rector of the University or the person performing the duties for enrollment in the University on a fee-paying basis.

- 6.22 The application must be accompanied by the UNT certificate, and a copy of the transcript signed by an authorized person and sealed.
- 6.23 After receiving a document on general secondary or technical and vocational, post-secondary education, applicants submit the documents specified in Appendix 3 to the Model Rules.
- 6.24 After receiving a notification of acceptance of documents for enrollment in the OVPO in the 'personal account" of the portal, the service recipient submits the original documents to the service provider within the period from August 10 to August 25 of the calendar year.
- 6.25 If an incomplete list of documents specified in the Model Rules is provided, the Admissions Committee will not accept documents from applicants.
  - 6.26 Admission to the University is carried out separately for higher education programs.
- 6.27 Admission to higher education programs for which creative examinations have been established is carried out considering the scores on these examinations, with the exception of applicants to related areas of higher education that provide for shortened periods of study.
- 6.28 If an applicant applies for an education loan issued by a second-tier bank, the applicant is enrolled as a student at the University upon presentation of a corresponding certificate from the bank stating that the documents are under consideration.
- 6.29 In this case, he is granted a deferment on payment of the amount specified in the contract for the provision of education services and payable before the citizen is enrolled, for the period of registration of the education loan, but not more than 4 (four) weeks from the date of receipt of the certificate from the bank.

# 7 PROCEDURE FOR ADMISSION AND ENROLLMENT OF FOREIGN CITIZENS

- 7.1. Admission of foreign citizens based on an education grant and on a fee-paying basis is carried out in accordance with Article 9-1 of the Law.
- 7.2. Admission of foreign citizens on a fee-paying basis is carried out based on the results of an interview conducted by the Admissions Committee during the calendar year. The interview is conducted orally in online/offline mode. The interview involves the presentation of one's own thoughts, expressing individual impressions and considerations on a specific situation (a question related to the content of the Education Program chosen by the applicant), which is not intended to be a defining or exhaustive interpretation of the subject.
- 7.3. Enrollment of foreign citizens is carried out in accordance with the academic calendar 5 (five) days before the start of the next academic period.
- 7.4. Education documents issued by foreign education organizations undergo the procedure of recognition of education documents in accordance with the procedure established by the legislation of the Republic of Kazakhstan after enrollment of persons during the 1 (first) academic period of study.
  - 7.5. The process of nostrification of education documents is carried out by the student him/herself.
- 7.6. To be admitted to the University, foreign applicants submit to the University Admissions Office the following package of documents:
- 7.6.1. Application addressed to the Chairman of the Board Rector of the University by email to int@iitu.edu.kz;
- 7.6.2. A notarized (Kazakhstan notary) copy of the passport with a translation into Kazakh or Russian. The validity period of the national passport must be at least 2 years from the date of entry into the territory of the Republic of Kazakhstan;
- 7.6.3. Original certificate of completion of a school/college, supplement to the certificate/diploma (transcript) indicating the subjects completed, grades, etc.;
  - 7.6.4. Certificate of complete secondary education;
- 7.6.5. Notarized and apostilled translation of the certificate of completion of a school/college, supplement to the certificate/diploma;
  - 7.6.6. If available, send valid scanned copies of IELTS/TOEFL certificates:
- 7.6.6.1. IELTS Academic (International English Language Testing System Academic) score no less than 5.5; TOEFL IBT (Test of English as a Foreign Language Internet-based test), score no less 46;

- 7.6.6.2. TOEFL ITP (Test of English as a Foreign Language Institutional Testing Programm), score no less 460;
- 7.6.6.3. University certificate of passing the English language exam not less than 30 points out of 50 (60%):
- 7.6.6.4. Certificate of completion of the course "IITU Academic English Course" at the University's language center "LINGUA";
  - 7.6.6.5. Certificate of "KBTU" JSC on passing internal entrance examinations;
  - 7.6.6.6. Certificate of Astana IT LLP on passing internal entrance examinations;
- 7.6.6.7. Certificates of completion of courses on the programs of internal entrance examinations at KBTU JSC or Astana IT LLP.
- 7.7. Medical certificate form 075/U. Certificates are issued upon arrival in Kazakhstan, after passing the relevant medical examination. The seal of each doctor and the round seal of the medical institution in the lower left corner is mandatory.
  - 7.8. Fluorography image.
- 7.9. If an incomplete list of documents is provided, the Admissions Committee reserves the right to refuse a foreign applicant.
- 7.10. After enrollment, a foreign student must go to the Department of International Affairs and Academic Mobility to obtain temporary registration/visa (depending on the country of arrival). If the student is outside the Republic of Kazakhstan and is unable to enter the country without a visa, the Department of International Affairs and Academic Mobility of the University issues an invitation for the student through the Migration Services Center (the student pays 0.5 MCI, the response period is 7 (seven) working days).
- 7.11. A student who has received temporary registration or a visa is obliged to notify the Department of International Activities and Academic Mobility of the University of each arrival and departure from the Republic of Kazakhstan within one calendar day.
